

END USER LICENSE AGREEMENT (EULA)

Effective Date: The date of acceptance of this Agreement and use of the software. This End User License Agreement ("Agreement") is a legal agreement between you ("User" or "you") and **OGI Bio Ltd**, a company registered in Scotland with company number SC654285 and a registered office at Floor 3, 1-4 Atholl Crescent, Edinburgh, EH3 8HA, United Kingdom ("Company," "we," "us," or "our"), for the use of the **Ogibiotec** application ("Application").
